GENERAL INFORMATION

ELIGIBILITY: Camp is open to youth entering 7th through 12" grade this fall (2026-2027 school year).

TOTAL COST: is \$65 per person – Non-Refundable (Family Discount: 2 or more registered teens per household may deduct \$10 per registrant)

DUE BY: June 27, 2026--\$10.00 late fee applies to any applications received between June 22nd & July 5th. You may not attend camp without all forms being completely filled out, signed, and turned in with the fee by the deadline! Limited exceptions only after July 7th. Forms turned in after June 27th may or may not receive a camp shirt

CAMP LOCATION AND TIMES

Camp officially begins on Sunday, July 5th, at 4:30 PM sharp when the van departs from the church parking lot for Prince Gallitzin State Park in Flinton. We will be camping at the Organized Group Tenting Area (near public beach & picnic area #3). Camp ends on Friday afternoon, July 10th at 4:00 PM. Parents, please plan to pick up your teen at the church then.

ACTIVITIES

Swimming, canoeing, fishing, hiking, and scheduled events are all included in the cost of camp. If you plan to fish, bring a fishing rod, & tackle with you. Live bait will be furnished. If you are 16 years of age or older and plan to fish, you must bring a valid fishing license provided at your own expense.

Teen Camp Code of Conduct

Our Purpose of the Church: Through loving and caring relationships empowered through knowing Jesus Christ, we want to impact the Moshannon Valley and Beyond with God’s Word so that all may know Him.

Our Code of Conduct is intended to complement our purpose of encouraging and equipping students to impact their world through knowing Christ. The code of conduct is meant to help us as we strive to create and maintain an atmosphere that glorifies God by:
(1) Maintaining a group testimony for Jesus
(2) Respecting and valuing others. Those participating in teen camp are required to honor the following Code of Conduct:

1st We will participate and contribute in a positive way to the camp program, which includes lesson, devotions and activities. We will not 'skip-out" or leave without permission on lessons or activities. We will show respect to those in authority. We will not cause disruptions during teaching times. To encourage group unity, we will make an effort to be in all activities and be a team player as much as we are physically able.

2nd We will use appropriate language (no cursing, crude language, put-downs or gossip). We will treat each other with respect to their feelings and well-being therefore will not engage in harmful horseplay and teasing of others.

3rd We will respect the personal property of others. We will observe the rules, policies and safety measures of the facilities being used. If involved in property damage, we will be required to compensate for damages.

4th The way we dress will be decent and modest. When we participate in swimming events, ladies will wear modest one-piece suits, 2-piece bathing suits will have a non-white cover-up. Those with earrings and body piercings may be asked to remove them during physical activities to prevent unnecessary injuries.

5th To maintain our witness during camp, we will not pair off with the opposite sex. We will avoid physical expressions of affection with the opposite sex (holding hands, kissing, hugging, sitting on laps, and sleeping or lying next to one another, etc.)

6th We will not possess or use controlled substances (Vapes tobacco products, non-prescription drugs, alcoholic beverages, drugs or drug paraphernalia, etc.) We will not bring weapons, knives, guns, chains, etc.

7th We will not possess, or look at restricted materials or obscene or pornographic materials.

8th We will not bring video games, radios, tape or CD players, I-Pods, etc. Music will be provided by the leaders. Cell phones will be collected and limited to only necessary communication with our family. We will not use our cell phones recreationally for calling or texting during camp.

9th We will remain within established camp boundaries unless granted permission by adult leaders.

10th We know that visitors to the camp are not permitted except with approval from the camp directors. We will not bring a vehicle to camp except by prior approval from the camp director for employment purposes.

11th We will complete our assigned tasks without complaining. We will seek to enjoy ourselves and help others to enjoy teen camp through our positive participation, interpretation and enforcement of this Code of Conduct is subject to the discretion of the Camp Staff.
